# 1 INTRODUCTION

## 1.1 Approval under the Environment Protection and Biodiversity Conservation Act 1999

The Department of Environment issued approval for the Taxiway Zulu and northern compound project at Melbourne Airport on 9 January 2018. Summary details of the approved action are included in Table 1 below.

### 3 SUPPORTING INFORMATION

#### 3.1 Condition 1 – Progress of project in the reporting period

Figure 1 shows the current status of work zones within the project. There were no active works during the majority of the reporting period (July 2023 to April 2024). Works in Zones SP2 and SP3 re-commenced on 22 April 2024. No NTGVVP was removed during the reporting period.

### 3.2 Conditions 4 and 5 – Implementation of the CEMP and PFAS Management Plan

Since commencement of the action, APAM has implemented an audit and inspection schedule to verify implementation of the approved CEMP and PFAS Management Plan. A summary of the audit and inspection activities conducted within the reporting period is provided in Table 3.

Works re-commenced in SP2 and SP3 on 22 April 2024. During the period 22 April – 1 July 2024 two inspections were completed. Inspections of the Temporary PFAS Soil Storage Facility continued on a bi-monthly frequency throughout the reporting period as the facility remained operational.

Through implementation of the inspection schedule, several corrective actions were identified and closed out during the reporting period. An example of key corrective actions for the reporting period is provided in Table 4 below.

**Table 4: Example of key corrective actions for the reporting period**

Project area	Issue identified	Resolution
Taxiway Zulu	Portable concrete washout skips required emptying to ensure risk of overflow is managed.	Skips emptied to ensure adequate capacity for future concreting works.
Taxiway Zulu	Crushed rock hardstand at concrete batching plant not being managed appropriately leading to sediment being tracked onto internal roadway.	Additional controls installed to prevent degradation of hardstand (additional rock at entry/exit points) in addition to more regular street sweeping services.
