

## Invitation for Public Comment:

### Future Airfields Projects, Melbourne Airport, Tullamarine, Victoria (EPBC 2024/09907)

The following notice is published pursuant to Section 95A (3) of the Commonwealth *Environment Protection and Biodiversity Conservation Act* 1999 (EPBC Act).

Australia Pacific Airports (Melbourne) Pty Ltd is proposing a series of maintenance and upgrade projects on the airfields over the next 5-10 years. This includes:

- Airfield Renaming - Current taxiway naming system will run out of single-letter identifiers. Renaming required before third runway opens for clear identification.
- Melbourne Airport Pavement Maintenance Project (MAPMP 3.0) - Long-term maintenance for aging airfield pavement (drainage, pavement, apron replacement). New construction hardstands needed north of airfield for reduced travel for construction vehicles, site amenities, offices, staff parking, material and plant storage.
- Runway 09/27 Overlay – Upgrades to airfield ground lighting to meet updated standards
- Hotel Apron South – increased parking standards for growing demands from post-COVID recovery.
- Staff Car Park Extension – staff carpark expansion to accommodate for growing workforce at the airport.

The proposed action is deemed a controlled action under the EPBC Act. The controlling provisions under the EPBC Act are ‘Commonwealth land’ (Sections 26 and 27A) and ‘listed threatened species and communities’ (Sections 18 and 18A), specifically the *Natural Temperate Grassland of the Victorian Volcanic Plain* ecological community. No other matters of national environmental significance are likely to be impacted.

Australia Pacific Airports (Melbourne) Pty Ltd is now inviting public comments on the documentation that will be used to assess the proposed action under the EPBC Act. This documentation is on display from Thursday 27 November 2025 until Wednesday 10 December 2025, free of charge at the following locations:
