To apply, the organisation you are applying on behalf of must meet the following criteria:

- sits within one of the local government areas highlighted in the map (below left)
- 2 does not owe any reports or money to Melbourne Airport from previous funding or grants (please note details of any outstanding reports or monies)
- activities that are the subject of this funding application
- 4 If applicable, please note if the organisation you are applying on behalf of has deductible gift recipient (DGR) or Tax Concession Charity (TCC) status or is auspiced by an organisation with DGR & TCC status.

You must also confirm that this application is NOT for:

- (a) capital expenditure
- (b) professional development
- (c) a political or faith-based cause
- (d) projects already fully funded by the government
- (e) general operating support

Applications will be accepted all year round.

Applications will be assessed and applicants will be notified of the result of their application within one month of the application being received.
